THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD ACT

Regulations made by the Minister, after consultation with the Construction Industry Development Council, under section 34 of the Construction Industry Development Board Act

- 1. These regulations may be cited as the Construction Industry Development Board (Registration of Consultants, Contractors, Service Providers and Suppliers) (Amendment) Regulations 2022.
- 2. In these regulations
 - "principal regulations" means the Construction Industry Development Board (Registration of Consultants, Contractors, Service Providers and Suppliers) Regulations 2014.
- **3.** The principal regulations are amended by revoking the Schedule and replacing it by the Schedule set out in the Schedule to these regulations.
- **4.** These regulations shall be deemed to have come into operation on 1 January 2022.
